**Notice of Draft Minimum Requirements for Developmental
Resources & Bidders Conference**

Minimum Requirements

Please be advised that a draft of the Minimum Requirements for developmental resources (described in the notice of the 2015 ETI RFP (“RFP”) dated April 30, 2015) is now posted on the RFP website, <https://spofossil.entergy.com/ENTRFP/SEND/2015ETIRFP/Index.htm>, under the “Notifications” tab. It is highly recommended that Bidders interested in submitting a proposal based on a developmental resource into the RFP review the draft Minimum Requirements document.

Bidders Conference

Entergy Services, Inc. (“ESI”), on behalf of Entergy Texas, Inc. (“ETI”), hereby issues notice of a Bidders’ Teleconference/Webcast for the RFP (“Bidders Conference”) on May 27, 2015. The Bidders Conference will be conducted by teleconference and web conferencing. The objective of the Bidders Conference is to give participants a high-level overview of, and other information concerning, the RFP and related processes. The Bidders Conference will be open to all interested persons. ETI and ESI personnel will provide information about the RFP at the Bidders Conference and be available to answer questions about bidder registration, proposal submission, the proposal evaluation process, technical RFP issues, and high-level commercial terms and conditions, including the Minimum Requirements for developmental resources. The Independent Monitor for the RFP, Mr. Wayne Oliver, will also participate and be available to answer questions regarding the RFP process.

ESI encourages bidders to submit RFP-related questions they desire to have addressed at the Bidders Conference in writing to the RFP Administrator and the Independent Monitor in advance of the Bidders Conference. ESI may be in a better position to respond more fully to questions submitted in advance of the Bidders Conference than to those submitted at the conference.

Bidders are strongly encouraged (but not required) to participate in the Bidders Conference. ESI will post the written materials expected to be presented during the Bidders Conference to the RFP website. The posted materials may not duplicate all of the information made available at the Bidders Conference. In addition, ESI will provide written responses to all questions submitted before and during the Bidders’ Conference and will post the questions and answers on the RFP website.

ESI requests that participating organizations register with the RFP Administrator, by electronic mail, no later than May 22, 2015. The registration notice should specify the name of the participating organization, as well as the name, title, and contact telephone number(s) of each individual representing the participating organization during the Bidders Conference. Once the RFP Administrator receives a registration notice for a conference participant, the RFP Administrator will provide the dial-in/Webex/Live Meeting details to the registered participant(s).
