Bidder will remit to ELL, by wire transfer to the wire address set forth in such invoice, full payment of such invoiced amount by the Proposal Submission Fee Payment Deadline (see Section 4.1 of the Main Body for the schedule in effect at the time the RFP was issued). In the event that Bidder does not pay the proposal submittal fee for a proposal, the proposal(s) will be considered non-conforming and eliminated from further consideration under the RFP.
