## **Bidders Conference:**

The registration notice should specify the name of the participating organization, as well as the name, title, email address, and contact telephone number(s) of each individual representing the participating organization at the Bidders Conference. Once a registration notice for a conference participant is received, the Bid Event Coordinator will provide the dial-in/Webex meeting details to the registered participant(s). After the Bidders Conference, ESL will post the written materials presented during the conference to the 2022 EML Fall Renewables RFP Website.

EML encourages bidders to submit RFP related questions they desire to have addressed at the Bidders Conference in writing to the Bid Event Coordinator via the RFP Inbox and the Independent Monitor via email (<a href="MerrimackIM@merrimackenergy.com">MerrimackIM@merrimackenergy.com</a>) ("IM Inbox") in advance of the Bidders Conference.

To allow ESL and EML adequate time to prepare their responses for presentation at the Bidders Conference, we ask that questions be submitted no later than December 1, 2022. Questions submitted after December 1, 2022, may not be addressed during the Bidders Conference. However, written responses to questions not addressed during the conference will be provided and, subject to limited exceptions, posted on the RFP website's "QA" section, along with those addressed during the conference.

## **Bidder Registration:**

To be eligible to submit a proposal, Bidder must complete the Bidder Registration Process during the Bidder Registration Period. To register for the 2022 EML Fall Renewables RFP, Bidders must submit a completed Bidder Registration Form and Agreement to the Bid Event Coordinator via the RFP Inbox, copying the Independent Monitor via the IM Inbox, by the Bidder Registration Deadline. Bidder Registration is scheduled to begin at 8:00 a.m. CPT on January 3, 2023, and to be available until 5:00 p.m. CPT on January 6, 2023.
